## Drug and Alcohol Testing

We would like to take this opportunity to tell you about the services that Clinch Valley Community Action, Inc. (CVCA) can provide for your business and employees.

CVCA has trained staff that can provide random drug and alcohol screenings at a very competitive rate. Drug and alcohol screenings can be run at your business or at the offices of CVCA. CVCA can be responsible for providing the random order in which your employees are to be screened.

CVCA provides a weekly substance abuse education class taught by a certified substance abuse counselor. Classes are held each Tuesday from 6:00 p.m. to 7:30 p.m. The counselor, a certified CSAC, uses a MATRIX curriculum. Fee is \$150.00

CVCA also provides a monthly 6-hour Alcohol Education class. Those attending the class, participate in a curriculum dealing with alcohol and drug abuse. Fee is \$35.00

Certificates are given to each individual who successfully completes one or both

## CVCA will:

- ◆ Schedule random drug and/or alcohol screening
- ◆ Drug screen and/or alcohol screen each individual as randomly selected
- ◆ Will run drug and/or alcohol screenings when called upon by the business.
- ◆ Will submit an invoice for payment at the end of each month for all screens run for your business.

## Business will:

- ◆ Call CVCA to discuss the details of screening needs.
- ◆ Pay an additional \$45.00 per drug, if a positive screening is sent to the laboratory for confirmation. This does not include screenings run for Department of Transportation employees or a DOT certified driver.
- ◆ Submit payment within 30-days for all invoice submissions for screenings.
